Privacy Policy

We collect your Personal information for the primary purpose of providing our services to you, providing information to our clients and marketing. We may also use your personal information for secondary purposes closely related to the primary purpose, in circumstances where you would reasonably expect such use or disclosure. You may unsubscribe from our mailing/marketing lists any at time by contacting us in writing.

When we collect Personal Information we will, where appropriate and where possible, explain to you why we are collecting the information and how we plan to use it.

Sensitive Information is defined in the Privacy Act to include information or opinion about such things as a individuals racial or ethnic origin, political opinions, membership of a political association, religious or philosophical beliefs, membership of a trade union or other professional body, criminal record or health information.

Sensitive information will be used by us only:

- For the primary purposes for which it was obtained
- For a secondary purpose that is directly related to the primary purpose
- With your consent: or where required or authorised by law.

Third Parties

Where reasonable and practicable to do so, we will collect your Personal Information only from you. However, in some circumstances we may be provided with information by third parties, in such cases we will take reasonable steps to ensure that you are made aware of the information provided to us by a third party.

Disclose of Personal Information

Your Personal information may be disclosed in a number of circumstances including the following:

Security of Personal Information

Your personal information is stored in a manner that reasonably protects it from misuse and loss and from unauthorised access, modification or disclosure.

However, most of the Personal Information is or will be stored in client files which will be kept by us for a minimum of 7 years.

GreenHy2 will not charge any fee for your access request but may charge an administrative fee for providing a copy of your Personal information.

In order to protect your Personal Information, we may require identification from you before releasing the requested information.

Maintaining the Quality of your Personal Information

It is important to us that your Personal Information is up to date. We will take reasonable steps to make sure that your Personal Information is accurate, complete and up to date. If you find that the information we have is not up to date or in inaccurate, please advise us as soon as practicable so we can update our records and ensure we can continue to provide quality services to you.
